Executive Summary

The year in review, present the University's newly achieved milestones in its four-fold functions namely: Instruction, Research, Extension and Production.

Guided by its vision, mission and goals, the University was able to accredit a total of 43 out of the 50 residential degree programs being offered by the University have undergone accreditation. All of the seven (7) PhD programs, and 21 out of the 26 MA/MS degree programs have undergone accreditation.

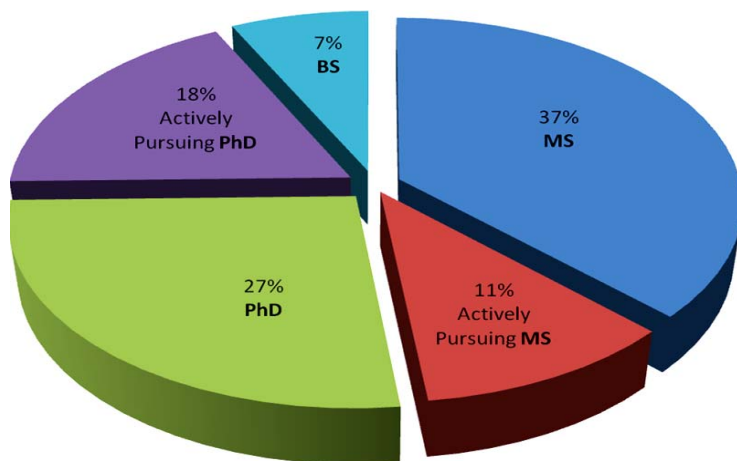


Figure 1. Faculty distribution according to educational qualification

Majority of BSU's Faculty are with advanced degrees; 27 % are with PhD., while 18% are actively pursuing their doctoral degrees; 37 % are masters degree holders, while 11% are currently enrolled for a master's degree and seven percent are baccalaureate degree holders. (see Figure 1).

Enrollment in the Main Campus is facilitated by the use of Student Information and Accounting Systems. Student Information (SI) includes registration/enrollment, curriculum evaluation, performance and class scheduling system. Accounting Systems (AS), on the other hand, include student ledger, assessment, accounts receivable, cashiering/ receipts, accounts payable, budget allotment and obligations, petty cash, disbursement voucher, journal entry voucher and general ledger.

The following graduates were among the Top 10 Placers in the PRC Licensure Examinations: Mark Michael S. Palazo, 1st Placer (Veterinarian), Jonathan I. Gayaso, 7th Placer (Teaching -Elementary) and Danni Loven A. Fulwani, 7th Placer (Teaching -Secondary).

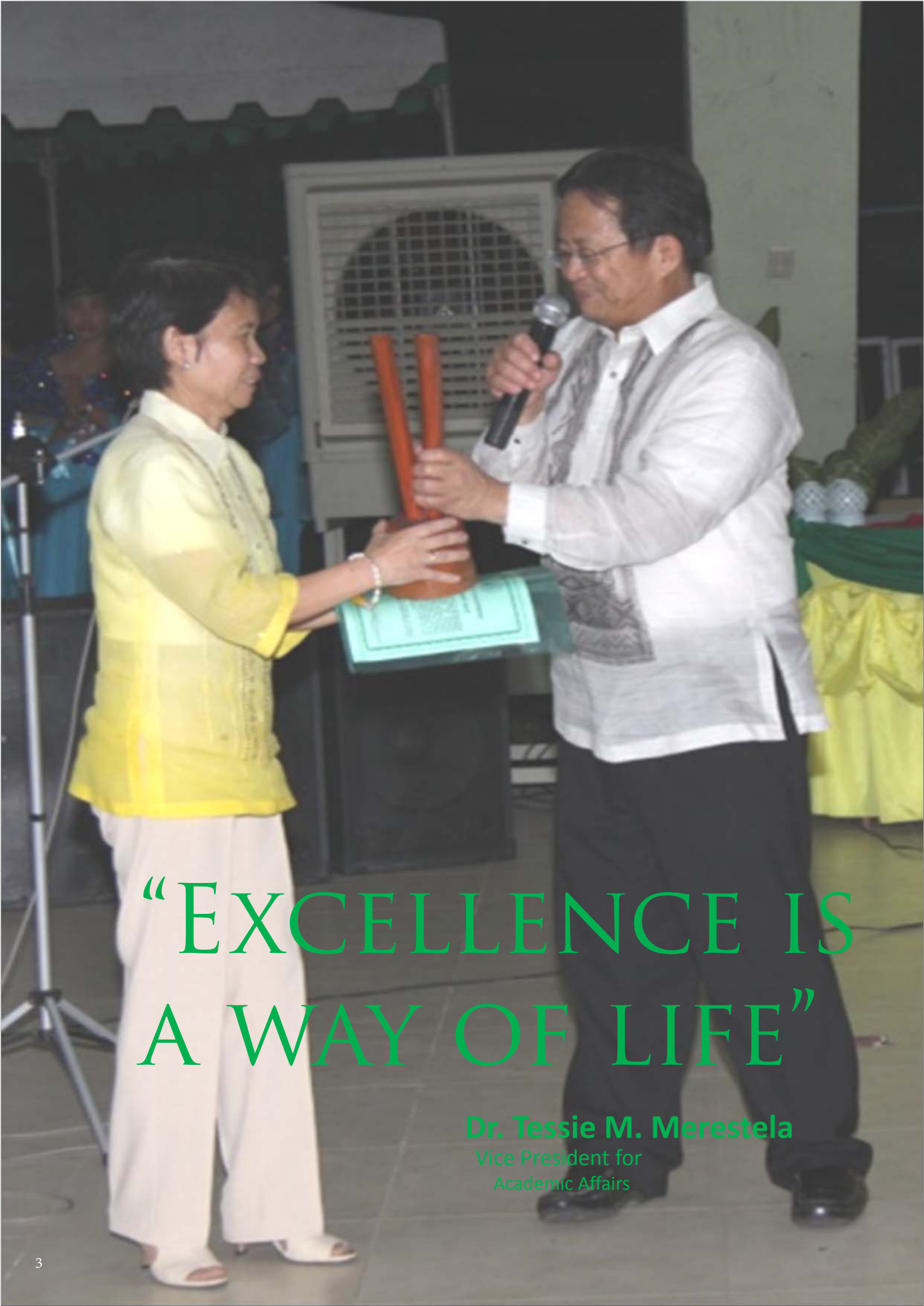
BSU financed the improvement of RDE facilities through renovations and repair of greenhouses, rearing houses and laboratories. Several ICT and office equipment and fixtures were acquired out of agency and donor funds. Grants from international and national donors were received for the implementation of RDE activities. Research and extension income to PhP 2,768,414.77 M.

A total of 166 RDE programs/projects were implemented for the year 2010. Out of this, 73 were completed, 52 were on-going and 41 new projects. The University conducted collaborative RDE projects with 30 local, national, and international partners.

The Philippine Institutional University Cooperation (PIUC)- Vlaamse Interuniversitaire Raad (VLIR) Project had its close-out activities in March 2010. The projects implemented in the University include: Information Technology Development, Library Development, Strengthening of the Institute of Social Science Research and Development, and the establishment of the Semi-Temperate Vegetables Research and Development Center. Dr. Darlyn D. Tagarino served as the PIUC-VLIR coordinator for BSU.

Source of disbursements includes the subsidy from the National Government thru General Appropriations Act , cash allocation of which is received from the Department of Budget and Management in semi-annual basis. Other sources of disbursements are the Special Trust Fund (RF 164) form the collection of tuition and other fees, and leases entered to by the university, income-generating projects (RF 161 and 163), and trust funds for grants and donations from outside agencies. Trust funds number more than twenty in 2010.

A. ACADEMIC UNITS & OFFICES

The academic programs of the University is spearheaded by the Vice-President for Academic Affairs who is also the Chair of the University Academic Council (UAC) composed of Deans and Directors who plan, formulate and recommend policies related to the overall implementation of the University’s academic program for endorsement to the Administrative Council.

The UAC is composed of the Deans and Directors of the colleges, institutes, the Open University and the Graduate School.

B. ACADEMIC PROGRAMS

The University offers 17 undergraduate courses, 32 graduate courses at the Graduate School and 7 at the Open University.

Apart from the regular course offerings, the International Language Center (ILC) offers *Intensive Functional English Language Program* for both foreign and local students.

C. FACULTY DEVELOPMENT

C.1. Faculty profile

The University's prime molders for academic development is composed of 307 faculty members of which 299 are permanent, and eight are on a contractual basis.

Majority of BSU's Faculty are with advanced degrees; 27 % are with PhD., while 18% are actively pursuing their doctoral degrees; 37 % are masters degree holders, while 11% are currently enrolled for a master's degree and seven percent are baccalaureate degree holders. (see Figure 1).

D. 4. International Language Center

The second batch was composed of 25 college students; 20 were from the Chungbuk National University and five from the Chungbuk Provincial College. A total of 43 out of the 50 residential degree programs being offered by the University have undergone accreditation. All of the seven (7) PhD programs, and 21 out of the 26 MA/MS degree programs have undergone accreditation.

Seven (7) programs from the Open University also passed the accreditation conducted by the Commission on Higher Education Central Office.

There are nine undergraduate and nine graduate programs that attained Level 3 accreditation status (Table 10).

N. 2. Student Development Unit

The Student Development Unit facilitated the processing and monitoring of student activities by Registered Student Organizations (RSO). The unit also assisted students who qualified for various leadership programs and nominations like the Ten Outstanding Students of the Philippines (TOSP), Ten Outstanding Youth Organizations (TAYO) and the 8th National Youth Parliament among others.

N. 4. Testing & Materials Development Unit

The Testing and Materials Development Unit conducted career guidance to 382 high schools students in St. Louis High School Philex in coordination with DOLE-CAR. The unit also administered College Qualifying Examinations (CQE) to more than 3,500 applicants.

N. 5. Placement & Alumni Unit

The Placement and Alumni Unit interviewed and facilitated the hiring of student assistants (Sas). The Unit also conducted an orientation for Sas as well as career coaching and personality testing to graduating students. There were 40 grantees for the BSU- SPES.

The ladies and men's dorm housed 178 and 116 students respectively.

N. 6. International Students Program

The OSA processed pertinent documents for foreign students such as passports, Alien Certificate of Registration and release of allowance among others.

O. ISO 9001:2008 Certification

Another effort being made by the university is the application for ISO 9001:2008. The Development Academy of the Philippines (DAP) was tapped to provide technical advice and guidance to the University in establishing its ISO 9001:2008 Quality Management System (QMS) for the different processes included in the certification of instruction services.

The University, upon the establishment of the QMS for its instruction services in compliance with the ISO 9001:2008 requirements will then apply for certification by an independent body. This effort was spearheaded by the University Planning and Development Office.

The year in review was very challenging yet rewarding despite upheavals in political and economic situations of the country. The past year brought the Research and Extension sector much closer to achieving its thrust and mission of the University.

In order to sustain these gains, BSU continued to support capability development of the RDE personnel. Some research and extension staff are taking graduate studies. A total of 68 researchers and support staff attended different local, national, and international training courses, seminars and workshops to enhance their competencies.

BSU financed the improvement of RDE facilities through renovations and repair of greenhouses, rearing houses and laboratories. Several ICT and office equipment and fixtures were acquired out of agency and donor funds. Grants from international and national donors were received for the implementation of RDE activities. Research and extension income amounted to PhP 2,768,414.77 M.

A total of 166 RDE programs/projects were implemented for the year 2010. Out of this, 73 were completed, 52 were on-going and 41 new projects. The University conducted collaborative RDE projects with 30 local, national, and international partners.

The technology and information generated from R&D activities were managed and disseminated through various means. The BSU-on-the-Air radio program utilized 59 hours of different topics on agriculture, processing of root crops food- based products and health over DZWT-AM. Extension services were also rendered by the R and E personnel as well the faculty members of the different colleges in the University to LGUs, farmers, teachers and other stakeholders.

Technology piloting, demonstration, and commercialization was conducted on bell pepper, cherry tomato, strawberry, banana colored callas, carnation, sayote, cape gooseberry, rattan and other high value crops.



A. Highlight of Technologies & Information Generated

A total of 13 RDE projects were monitored and evaluated by the Monitoring Team from January to December. Other projects were also monitored and evaluated by the Center/Institute Directors, Project Leaders and Study Leaders. General observations and recommendations are summarized in Table 20.

The record system of the OUBS is being converted to electronic for faster filing and retrieval of documents.

The Legal Affairs Office has processed 105 MOAs and participated in the establishment of linkages with local, national, and international institutions. The LAO also processed 166 legal documents like affidavits.

B.4. Planning and Development Office (PDO)

B.3.1. ICT Division

The ICT Division upgraded the University's bandwidth and the server. The university has expanded Internet access points by deploying wireless equipment thereby creating hotspots or Wi-Fi access points in strategic areas of the University. With single access point accommodating 50 simultaneous users, the 10 newly setup devices can accommodate up to 500 simultaneous Wi-Fi users. This aims to provide ease of Internet and LAN access to faculty, staff and students using their personal mobile devices such as laptops. Access points are installed at the main Library, ICT Office, CTE, CA, CAS Annex, CAS Main, High School, CHET and three in the administration building. The access points have been configured to provide separate signals for students and faculty. For the time being, access for students is offered for free.

Successful video conferencing test with AVNET, KUL, Belgium

Paul Garcia Jr. and Bert Driessens, technical staff of AVNET had a 20 minutes videoconference using the equipment issued by ASTI to HARDECC. The new ISP provided by Globe was used during the test.

The successful test suggests that the university is capable of initiating linkages with outside entities through video conferencing. Improvement of ICT resources is however necessary for developed communication experience. This includes the procurement of a new H.239 video conferencing equipment, identification of a dedicated video conferencing room and most importantly, upgrading the existing bandwidth.

B.5. Internal Auditing System (IAS)

The IAS prepared an Internal Audit Program & Internal Audit Plan for 2010, which was approved by the President for implementation, as follows:

A. Leave Administration

- To determine the reliability and accuracy of reports.

B. Employees Scholarship / Fellowships/ Trainings/ Grants/Sabbatical Leave

- To determine if prescribed policies and procedures are being complied with.

C. Verification and Post-audit of Financial Transactions

- To determine whether expenses are reasonable and in accordance with existing government laws, rules and regulations; and
- All collections received were properly accounted for and deposited promptly and intact.

D. Verification of Financial Reports/Statements

- To ascertain the accuracy and reliability of account balances as presented in the Financial Statements.

The activities done by the IAS for the year under report included the review of monthly statement of accountable forms, monthly financial reports, and daily sales reports.

In addition, the IAS conducted daily cash counts and participated in the year end physical inventory of supplies, furniture and equipment.

B.6. Special Projects

B.6.1 BSU-CICT Partnership

The BSU-CICT project continued to reach out to public high schools (PHS) in the region and nearby regions to conduct trainings and seminars for teachers and principals in various PHS.

BSU-ICT technical team installed computers in 12 new computer laboratories of PHS who are iSchool recipients.

B.6.2. University Eco-Waste Management

The University Eco-Waste Management Program conducted IEC Seminar-Training to students, faculty and staff. The program staff produced IEC materials in English and Tagalog.

Conducted Balili River Rehabilitation Stakeholders consultation on August 20, 2010 at the Strawberry Hall. Participants were NGOs, LGU of Baguio and La Trinidad, fastfood chains and individual groups. A workshop was conducted last Sep. 3, 2010 to prepare for the Balili River Summit.

B.6.3. Organic Agriculture Program

The Cordillera Organic Agriculture Development Center (COADC) attended as an exhibitor and lectured on "BSU: Organic Land Conversion" during the 3rd Pinoy Organic Festival held at the Memorial Circle, Quezon City from May 28-30, 2010. Sen. Juan Miguel Zubiri was the Guest Speaker during the festival and promised to support the organic center

B.6.4. Philippine Institutional University Cooperation Program-VLIR

The Philippine Institutional University Cooperation (PIUC)- Vlaamse Interuniversitaire Raad (VLIR) Project had its close-out activities in March 2010. The PIUC-VLIR Program involving the University and St. Louis University started in 1999. However, prior to the 10-year program, VLIR funded projects in BSU as early as 1995. The projects implemented in the University include: Information Technology Development, Library Development, Strengthening of the Institute of Social Science Research and Development, and the establishment of the Semi-Temperate Vegetables Research and Development Center. Dr. Darlyn D. Tagarino served as the PIUC-VLIR coordinator for BSU.

The project was evaluated by an external team. The evaluation result show that BSU implemented projects under the PIUC-VLIR Program garnered an overall rating of 100% achieved objectives for Infrastructure Investment Research Projects, 100% for non-degree programs and 80% for degree programs. The rating was based on the evaluation conducted by Flemish evaluator Mr. Ad Boen and external evaluator Dr. Robert Borrromeo.

B.7. University Public Affairs Office (UPAO)

The UPAO continued to perform its function in producing and updating the University's IEC materials. It published the monthly *SHAMAG*, the official newsletter of the University; 2010 graduation souvenir program, 2009 Annual Report, and souvenir programs for the 24th University Charter and 94th Foundation day anniversaries among others.

It also catered to more than 2000 visitors from institutions around the country including foreigners. The staff also documented University functions and events in and off campus by the different sectors.



A. CASHIERING SERVICES OFFICE

The Cashiering Services Office performs two general functions. These are disbursement functions and the collection function. Disbursements included those by check and by cash thru the cash advance of the disbursing officer. The collection function would necessarily include the deposit of collections with the bank.

Source of disbursements includes the subsidy from the National Government thru General Appropriations Act, cash allocation of which is received from the Department of Budget and Management in semi-annual basis. Other sources of disbursements are the Special Trust Fund (RF 164) from the collection of tuition and other fees, and leases entered to by the university, income-generating projects (RF 161 and 163), and trust funds for grants and donations from outside agencies. Trust funds number more than twenty in 2010.

In a nutshell, there were more than 9,500 disbursement vouchers and checks issued processed 2010 for all funds. Most disbursements are from the Special Trust Fund.

Collections are for RF 161, 163, 164 and a number of other trust funds in the university. For 2010, collections reached more than 77.9 million pesos, the bulk of which is for Special Trust Fund at 50.08 million.

Other Accomplishments and Innovations introduced in 2010:

- An additional Three million two hundred thousand (3.2 million) was placed in High-Yield Savings Account (HYSA). This was sourced from ordinary time deposits the university had.
- Computers were upgraded to cater to the installation/implementation of the collection system embedded in the Student Information and Accounting System.
- The university is now paying the wages of job order personnel thru Landbank's Cash Card facility.

B. ACCOUNTING OFFICE

The innovation introduced by the Accounting Office is the implementation of the Student Information and Accounting System (SIAS). It configured & re-configured Charts of Accounts, Schedule of School Fees and Other Fees in the SIAS among others.

C. BUDGET OFFICE

The Budget Office prepared the University's budget proposal for FY 2011. It also requested additional funds from the Department of Budget and Management (DBM).
