EXECUTIVE SUMMARY

The Benguet State University has achieved another remarkable year in operationalizing its four-fold mandates along instruction, research, extension, and production. Backed by the total support of the administration, milestones are herein reported, anchored on the six University goals.

Instruction. A total of 17 baccalaureate degrees, seven Doctor of Philosophy programs, and 34 MS/MA programs are offered at the Main campus. Bokod and Buguias campuses offer three and five baccalaureate degrees, respectively.

For the SY 2013-2014, BSU registered a total enrollment of: 3,125 for summer 2013; 9,705 for the first semester; and 9,261 for the second semester. At the end of the School Year, the University produced 1,358 graduates led by four *Magna cum laudes* and 58 *Cum laudes*.

A remarkable performance was noted in most of the results of licensure examinations taken by the BSU graduates: Jessica Eugenio placed 6th in the Veterinarian Exam, Irene Tuwao Alcantara placed 5th in Guidance Counselor, and Jemiah Lyn Bragado placed 9th in Nursing Board Exam. For Agriculturists, BSU listed a passing rate of 31.71%; Agricultural Engineers, 33.87%; Foresters, 38.46%; Nutritionist and Dieticians, 69.23%; Nurses, 99.15%; Librarians, 54.17%; and Veterinarians 40.38%. Moreover, the Elementary Teachers listed 60.87% and 68%, while Secondary Teachers listed 71.11% and 64.60% in March and September Exams, respectively.

Research. The University completed 58 studies within the year. The researches were on highland vegetables, strawberry, corn, coffee, education, socio-culture, and extension. Of these studies, a total of 27 papers/articles were published in various journals and books, 20 copyrights and 24 utility models registered and 4 Utility models applied for. Researchers were supported in their quest for knowledge having been sent to 79 international, national, regional, and local trainings, seminars, and conferences.

Extension. The office of the Extension Services, in coordination with the colleges and other offices connect with farmers and stakeholder-beneficiaries to share technologies, knowledge, and information meant to improve their livelihood and health as well as to increase their productivity through the conduct of wide range short-term training courses, seminars, and workshops.

Production. The income-generating arms of the University keep on augmenting and sustaining BSU's resources through efficient and economical management. This year, the Income Generating Projects had a total net income of PhP7,335,564.52 and PhP12,625,598.32 collected from land-use, buildings, spaces rentals, and other facilities accumulating an overall total of PhP 19,961,162.84.

Lastly, the University is now journeying ahead with courage and determination in achieving its vision of becoming "*A Premiere State University in Asia*" by sustaining excellence in its various degree programs and improving the delivery of its services.

I. STUDENTS

Enrollment

The total enrollment for all levels in the three campuses are as follows:




Figure 1. Enrollment in the different colleges and academic units for 2013

At the main campus, the College of Teacher Education has the highest enrollees among the colleges and academic units. The degree programs with the most enrollees for the 1st and 2nd semesters are BS Agriculture and BS Secondary Education. Figure 1 presents the distribution of enrollees of different colleges and academic units.

For SY 2013-2014, a total of **24** foreign students are currently registered to the different degree programs in the University, majority are from South Korea.

The total number of enrollees for the different programs being offered at Bokod campus are shown in Figure 2. There were **341** enrolled during the 1st semester and **319** during the 2nd semester of SY 2013-2014. The highest degree program with most number of enrollees was Bachelor of Science in Industrial Technology (BSIT).

The total number of enrollees for various degree programs offered at Buguias Campus is shown in Figure 3. There were **350** enrollees for the 1st and 319 for the 2nd semester of SY 2013-2014.

Graduates




Figure 4. Distribution of graduates during the three terms of 2013

A total of **1,358** students graduated in all programs during the 2nd semester of SY 2012-2013 led by four *Magna Cum laudes* and 58 *Cum laudes*, **70** students for summer 2013 and **152** students graduated for October SY 2013-2014. Figure 4 represents the distribution per college during the three terms.

The University continues to provide educational services through the Intensive Functional English Training Program (IFETP) and Test of English for Speakers of Other Languages (TESOL) of the International Language Center. This Year, 20 students graduated from the center, most of them are from South Korea (Table 1).




Figure 5. Summary of graduates at Bokod campus




Figure 6. Summary of graduates at Buguias campus




Figure 7. Distribution of academic awardees per college as of April 2013




Figure 8. The academic rank of faculty members in the University




Figure 9. Number of active library users for the year 2013




Figure 10. Distribution of papers presented during the 2013 agency inhouse review (AIHR)




Figure 11. Distribution of research papers presented in various symposia, conventions, and conferences




Figure 12. Distribution of trainings, seminars, and workshops attended by researchers

As part of their professional development, research personnel and staff attended a total of 88 trainings, workshop, and seminars all year-round (Figure 12).

Extension Services

Two RDE Seminar series were conducted with the following topics: a) Mainstreaming Climate Change Adaption and Mitigation Initiatives in Agriculture (AMIA) and b) Seminar/Outreach Presentation of Fulbright Programs. Other Relevant Activities

The R & E sectors commit to provide technical assistance to LGU's, NGO's, organizations, schools, farmers, students, and other recipients. A total of 50 different forms of assistance were noted within the year.

There were four technology programs/projects approved and implemented, three of which were funded by BSU-BVPC and one by RDA-South Korea. One R&D technology was packaged/commercialized and seven resources were received within the year. Technology promotion was also done through information dissemination during exhibits, marketing, and product promotion engaging the media (DZWT, PTV Channel 4), and in brochures, and IEC materials.

A total of PhP2, 404,312.04 were realized from the various income generating projects undertaken by the two sectors. Details of the incidental income generated from different R&E activities are presented in Table 22.

Public Affairs

Geographical Information System (GIS)

The database management for BSU reservation, including digitizing, analysis for BSU profiling, and a tool to provide the map requirements for BSU clients completed the ff: one GIS dataset for LRO survey data, three datasets for reservation land use map, customized maps as per requests of clients, and other similar concerns; GIS laboratory also assisted research, extension, and training as well as field data gathering activities during the year.

Legal Office




Figure 13. Cases handled by the Legal Office in 2013

The Legal Office handled 39 cases in 2013, nine of which were Court Cases, 16 Administrative Cases, and 14 other cases as shown in Figure 13.

Special Projects

National Organic Agriculture Development Center (NOADC)

Bearing the theme, "SUCs Collaboration for Effective Leadership in Organic Agriculture Industry Development," Benguet the State University, Department of Agriculture, and National Organic Agriculture Program hosted the SUCs 1st Consultation: The Role of SUCs in the Implementation of R.A. 10068 and National Organic Agriculture Program with 116 participants from different SUCs nationwide held on November 14-15, 2013 at the Supreme Hotel, Baguio City.

Pre-amalgamation Initiatives

Consultations on Amalgamation were conducted in the College of Nursing, discussed during Student Leader's meeting, and during the seminar on the implementation of K+12 by the Offices of Planning and Development and Vice-President for Academic Affairs.

The consultation result shows that out of 1,522 respondents, 738 (48%) were amenable to the establishment of a Regional University System in the Region. The most preferred model is the Accelerated Integration Model (39%).

LINKAGES

The successful implementation of the University RDE programs has been greatly enhanced through institutional linkages. This year, there were 15 institutional partners for projects/undertakings.
